The Fisher-Titus Foundation is a 501(c)(3) organization that supports the Fisher-Titus Medical Center, Fisher-Titus, Norwalk Memorial Home, The Carriage House, and North Central EMS by providing resources and building relationships that sustain and enhance operations. Proceeds from this Raffle will benefit new equipment, technology, and renovation of a Cardiac Cath Lab at the Snyder/White Heart and Vascular Center.

- ELIGIBILITY.** Each entrant, by entering the Raffle, agrees to abide by all of the rules and conditions contained herein, as well as all applicable local, state and federal laws and regulations, and further agrees to release the Fisher-Titus Foundation, Fisher-Titus, all its subsidiaries, and its directors, officers, agents and employees from any and all liability with respect to all aspects of the Raffle including, but not limited to, the selection process. The Raffle is open to any eligible person residing in a country or state where the Raffle is not prohibited. Entrants must be 18 years of age or older.
- TICKET PURCHASE.** The cost of entry for the Raffle is \$20 (U.S. dollars) for a single entry ("Entry") or three (3) entries ("Entries") for \$50 (U.S. dollars) and is not tax deductible. Any entrant may purchase more than one (1) Entry online from our secure website at [www.FisherTitus.org/donate](http://www.FisherTitus.org/donate) (click on Blooming Cash Raffle), by calling (419) 660-2920, by mail at Fisher-Titus Foundation, 272 Benedict Avenue, Norwalk OH 44857, or in person at any Fisher-Titus location (at the Medical Center in the Gift Shop near the Pavilion Entrance) or Sheri's Coffee, 27 Whittlesey Ave., Norwalk OH 44857. Mail-in forms can be picked up at any Fisher-Titus location. Entry payment can be made with credit card (online, at the Gift Shop, by phone or by mail-in), cash (at Fisher-Titus locations or from Fisher-Titus leaders), check or money order (at Fisher-Titus locations or from Fisher-Titus leaders), or GemPay (at the Gift Shop for employees only). If an entrant's payment is dishonored by the bank for any reason, such entrant's Entry will be declared invalid unless full and satisfactory payment is made prior to the Raffle drawing. Completed Entry(s) must be in the possession of The Fisher-Titus Foundation by 4:00pm on Monday, March 28 or before 3,200 entries are sold to be entered for the Grand Prize drawing. Entries received by 4:00 pm on Monday, March 7 will also be entered for the Early Bird drawing. All Entries will be handled on a first come, first served basis. Any Entry(s) and payments (including payments previously dishonored) received after closure of the Raffle will be returned to the Entrant. Upon receipt of a completed Entry (assigned a drawing number) and valid payment, an Entry will be entered. Information provided on the Entry will be used for the sole purpose of the Raffle and Fisher-Titus Foundation activities; information will not be shared with or sold to other organizations.
- GRAND PRIZE and BONUS DRAWING.** The Grand Prize is \$10,000 (U.S. dollars). Winners of both the Grand Prize and the Early Bird Prize will be selected by random drawings of all eligible Entries, submitted with completed Entry and valid payment, received by the entry deadlines described above under "TICKET PURCHASE." Winners need not be present to win. The Grand Prize drawing will be held at 4:30pm on Thursday, March 31 in the Fisher-Titus Patient Pavilion. Entrants are invited to attend the drawing in person (subject to COVID visitor restrictions), but the winner need not be present to win. An Early Bird Drawing will be held at 11:30 am on Thursday, March 10 in the Fisher-Titus Cafeteria for a \$1,000 (U.S. dollars) Early Bird Prize. Entrants for the Early Bird Drawing will consist of all Entrants who have submitted their entries (Entry and valid payment; see "TICKET PURCHASE" above) prior to 4:00 pm on Monday, March 7. The winning Early Bird entry will be returned to the entries for the Grand Prize drawing. The Grand Prize winner, as well as the winner of the Early Bird Drawing, will be presented with a check from the Fisher-Titus Foundation in the amount of their winnings within 5 business days of receiving the required completed forms from the winner. All prize winners are responsible for all costs associated with their winnings, including all applicable local, state and federal special and income taxes. Winners will be required to provide the Fisher-Titus Foundation with a valid social security number and must complete all IRS and similar forms requested by the Fisher-Titus Foundation prior to delivery of their prize. Failure to do so within thirty (30) days of request shall result in automatic forfeiture of such winner's prize.
- WINNING CHANCES.** A maximum of 3,200 Entries will be sold. Each Entry represents one (1) chance to win. You may enter as many times as you like. The chances of winning depend upon the number of eligible Entries sold. For the Grand Prize, if 3,200 total Entries are sold, your chances of winning are 1 in 3,200.
- MODIFICATION OF CANCELLATION OF DRAWING.** The Fisher-Titus Foundation reserves the right to cancel or modify the Raffle. If 1,250 Entries are not sold by 4:00 pm on March 28, The Fisher-Titus Foundation has the option to either withdraw the Grand Prize and split the net proceeds (income less expenses) equally between the Grand Prize winner and the Foundation, or to extend the sales deadline to meet the minimum number of Entries sold. If all available Entries are sold before the scheduled Grand Prize drawing date (i.e. The Fisher-Titus Foundation has determined that the Raffle has "sold out"), The Fisher-Titus Foundation reserves the right to end the Raffle early and draw the Grand Prize winner at a date earlier than the scheduled Grand Prize drawing date (to put the winnings into the hands of the winner sooner).
- WINNERS.** Winners will be notified by phone, email or mail based on the information provided on their Entry. Names of winners will be available to all media, on Fisher-Titus social media and on the Fisher-Titus Foundation website. Winning Entrants agree to allow The Fisher-Titus Foundation to use their name, likeness and any statements made by them regarding their prize for advertising or publicity around the current or future Raffle(s) without compensation. Winners may be required to complete and return proof of age, an affidavit of eligibility and liability release. Failure to do so if requested, or if the Winner otherwise fails to comply by these rules and/or fails to make arrangements to claim his/her prize within thirty (30) days of notification will void that entry.
- AWARDING OF PRIZES.** More than one (1) name may be listed on an Entry, but the first name listed shall be deemed to be the Entrant. Upon notification of winnings, the winner will provide a Social Security number, and it must be that of the Entrant (first name listed). Delivery or payment of any prize shall be made solely to the Entrant or Entrant's estate.
